

## South Carolina Long Term Care Emergency Preparedness Educational Program July 2021 - June 2024



The University of Georgia's Institute for Disaster Management in conjunction with local, state, and federal partners is pleased to announce the award of a three-year Centers for Medicare and Medicaid Services (CMS) Civil Money Penalty (CMP) funded grant, the South Carolina Long Term Care Emergency Preparedness Educational Program (SC LTCEPEP).

The SC LTCEPEP is for certified long term care facility staff, targeting administrators, activities directors, maintenance/engineering directors, clinical staff, and other non-clinical staff to develop knowledge, skills, and abilities related to emergency preparedness. As required by CMS Appendix Z, all four components of an Emergency Preparedness Program will be covered including: Emergency Plan, Policies & Procedures, Communication Plan, and Training & Testing Program. The knowledge gained in each course can be used to improve the health and safety of residents and staff members through emergency preparedness measures taken at the facility-level.

This program is for certified long term care facilities only. Assisted living facilities, personal care homes, hospice, or memory care centers are not permitted to attend due to the source of funding.

There will be two educational courses offered throughout the program. In Year 1, eight Basic Courses were offered. Year 2 courses are now open for registration! See below for more details.

- Year 2: Basic Course and Advanced Course, 1 of each offered in each healthcare coalition (8 total)
- Year 3: Basic Course and Advanced Course, 1 of each offered in each healthcare coalition (8 total\*)
